## Introduction o\_

The aim of the project is to investigate Public History and its relationship with the History of **READING AND LIBRARIES**. Experiences of Public History can be developed in connection with the historical-educational field through the involvement of different subjects and to support the meeting between the academy and social memory. A new partnership to enhance the past and to promote the critical understanding of the present.

# Object of Research

#### Madeleine in Biblioteca

The main project is "Madeleine in biblioteca" in collaboration with libraries and book clubs. Its aims is to recover people's reading memories from childhood to adulhood.

The autobiographical memories of readers represent an important sources and some scholars have stressed the importance of diares , letters and oral testimonies: Michèle Petit (1993), Martyn Lyons e Lucy Taksa (1992), Janice A. Radway (1984), Sarah McNicol (2007).

Focused on important informal leaning the project involves:

- 1) oral testimonies collection
- 2) The website www.madeleineinbiblioteca.it A digital space to return the collected testimonies to the community, inspired by the english database Red (Reading experience database)
- 3) Workshops realized with the oral sources collected (censorship, family education, women's reading, children's books) to reflect on the history of reading using the historical narratives of non-specialists (integrated with the testimonies found in Diary archive of Pieve Santo Stefano)


